### **NQF** landscape:

 NQF Act (No 67 of 2008) makes provision for an integrated NQF comprising three sub frameworks, each developed and managed by a Quality Council

### **Occupational Qualification**

SDA: 'Occupational Qualification means a qualification associated with a trade, occupation or profession resulting from work-based learning and consisting of knowledge standards, practical standards and work experience standards'



# Purpose of Occupational Qualifications

The purpose of an occupational qualification is to qualify a learner to practice an occupation, reflected on the Organising Framework for Occupations (OFO) or an occupational specialisation related to an occupation that is reflected on the OFO this includes those occupations for which artisan qualification is required (trades)

Learner enrolment- is reported on quarterly to the QCTO

External Integrated Summative Assessment is conducted through accredited Assessment Centres

Learner results are communicated to the QCTO by the AQP for Certification of Learnes

#### **QCTO MANDATE & FUNCTIONS**

#### Policy adjustment

- OQSF (distinction from other two Councils, through experience to adjust how Occupational Qualifications are developed, responsive to industry requirement)
- CAT (full acknowledgement of credits in the sub-framework however across the three Frameworks it is work in progress)
- ARTICULATION : Articulation in terms of subject to modules, in the qualification or in addition to qualification)
- RPL: it is the responsibility of the AQP to ensure that the policy is in place



#### **QCTO MANDATE & FUNCTIONS**

- Policy Shifts
  - Realignment of legacy qualifications (historically registered qualifications, more than one into a single occupational Qualification)
  - Part Qualifications (lead to employment) & Part of a Qualification
  - Skills Programmes converted to part qualifications; Some skills programmes are required for employment e.g first Aid, Working at Heights as part of a qualification
  - Reconstructing the N4; N5 & N6 into Occupational Qualifications



## CHALLENGING OPPORTUNITIES FOR TVET COLLEGES

- Programmes will no longer be based on trimester (Competency based training)
- Partnerships between Colleges and Industry
- Defined working relationship amongst SDPs (TVET) & Learners & Employers
